Will the following be located on the parcel no less than 25 feet from any dwelling on an adjacent parcel: the structure in which the hens will be kept or confined, any optional covered fence enclosure, and any structure in which the feed and other items associated with the hens?

Does the applicant agree that no hen will be slaughtered on the parcel outdoors?

Note: If a license is granted as a result of this application, it will be valid for one (1) year only. The permit can be renewed annually upon inspection of the property by a village official to assure continued compliance with the ordinance. A license renewal fee will also be required.

Violations

Any person who violates any provision of this Chapter shall be responsible for a municipal civil infraction as defined in Public Act 12 of 1994, amending Public Act 236 of 1961, being Sections 600.101-600.9939 of Michigan Complied Laws, and shall be subject to a fine of Five Hundred and 00/100 (\$500.00) Dollars. Each day this Chapter is violated shall be considered a separate violation.

Enforcement Officials

The village clerk and police officers of the Village of Bellaire are hereby designated as the authorized officials to issue municipal civil infractions directing alleged violators of this Ordinance to appear in court.

Civil Action

In addition to enforcing this Ordinance through the use of a municipal civil infraction proceeding, the Village may initiate proceedings in the Circuit Court to abate or eliminate the nuisance per se or any other violation of this Ordinance.

If the requirements of Chapter 30 are not complied with, the Village may revoke any permit granted and/or initiate prosecution for a civil infraction violation. A person who has been issued a permit shall submit it for examination upon demand by any police officer or code enforcement officer.
