The Council then discussed a couple of the revenue sources that were mentioned at the previous budget meeting. Marijuana sales were mentioned along with the pros & cons of allowing it in the Village. It was noted that the taxable value in the Village increased and will bring in additional revenue that was not expected. It was also noted that according to the audit, we didn't use as much fund balance as projected last year. New construction being built in the Village will also bring in additional tax revenue. Registration fees and taxing short-term rentals were also discussed. We would have to determine if the revenue generated from registration fees and from taxation would be worth the costs of implementation and enforcement. We currently do not regulate short-term rentals, but the Village can pursue that option. It was noted that we have started working on some of the additional revenue sources that were brought up, such as the police millage and grants. We can begin discussing expenditures at the next meeting.
